To the very kind gentlemen who gave my dad a 21-gun salute and TAPS.

Dear Sirs:

I do not know you and we did not get to meet. It was a rainy day and you waited in the rain until the interment of my father. It was April 26th of this year. On a beautiful, sunny day, what you do is quite moving and appreciated. But on a day when rain was pouring down and you stand at attention, dripping wet, in honor of a fellow soldier whom you've never met, it is indeed and honorable act. We are very grateful! Thank you for you service!

You men, who knew not my Dad, gave him a very great honor with the 21-gun salute and TAPS. I do not want you to think it went unnoticed or unappreciated. JOHN SPARKS, LIFE MEMBER

Excerpts for THE PULSE, December 2015.....



April 14, 1973

"I've spent five years dreaming of this day, of the day of my return to my family, to my country, to my people." Sparks told the crowd of 300 admiring students, city and civic officials, and others: "God bless you and may God bless this wonderful country of America, my home."

John Sparks, U.S. Army, was flying a reconnaissance mission over enemy territory on April 24, 1968 when his twin-engine OV-1 Mohawk was hit by anti-aircraft fire. With both engines gone, he and the pilot ejected over a heavily wooded area near the Laotian border. Sparks was captured and spent nearly five years in the Hanoi Hilton, the soldiers' euphemism for the most despicable prisoner-of-war camp in North Vietnam.

By any measure, most people would think that John Sparks had given enough of himself—for his country, his community. But there's something about veterans that makes them want to give more. Sparks says he feels fortunate: that the country and its people have given him so much that he feels obligated to give back. "Many didn't have the opportunity to come back and serve the community like we are able to do," explains Sparks, "and that's actually a privilege for us."

The information given in this story about John Sparks was just about all The Pulse could get. He was very tight-lipped about the amount and extent of work donated by him and his comrades except to say that veterans—mostly older veterans who are retired—have the time, energy and know-how to get things done. To get things done on time and within a budget.



RAY ADKINS HONORED FOR SERVICE

On Monday night at the VVA Chapter 203 monthly meeting a special ceremony was held to honor one of its own. Lt. Colonel Ray Adkins was inducted into the **Order of Saint Maurice**, by Colonel Larry Stovall and 203 member Bud Alley. Adkins has long been a fixture of veteran's service in the Chattanooga area. He was previously honored as Veteran of the Year by the Chattanooga Veterans Council among his other awards. Adkins, while a reserve officer, was called to active duty on numerous occasions.

In front of his brother and wife and members of Chapter 203, Adkins received the honor that is awarded to infantry soldiers who have distinguished themselves for contributions to, and loyal support of the Infantry and demonstrating gallant devotions to the principle of selfless service embodied in the American Infantryman. It is the highest noncombatant honor awarded to former infantry soldiers. **The Order of Saint Maurice** has its origins in the Thebes Legion in 287 AD when it defied the orders of Augustus Maximillian Hercules to perform pagan rites and kill innocent civilians. Facing death for its refusal, St Maurice was martyred along with the entire legion. He was declared a Saint by the Catholic Church and designated the protector and patron saint of sword-smiths and Infantry soldiers.

Here's another way to determine eligibility for VA disability benefits

The National Veterans Legal Services Program (NVLSP and on Facebook) is offering a free online app for veterans at <http://app.nvlsp.org>. It is designed to help veterans and their advocates identify the VA disability benefits to which they may be entitled. By answering a series of questions, the specific disability benefits claims that could be filed with the VA are identified. The app is available through the Apple app store and Google Play.

The questionnaire covers claims for service connection and non-service connected pension benefits only. It will not: assist veterans with claims for an increase in disability ratings the VA has already assigned for disabilities connected to military service; benefits based on claims previously filed with the VA; or benefits for disabilities that are the result of VA health care, VA vocational rehabilitation or participation in a VA Compensated Work Therapy program.

All NVLSP's legal assistance to veterans and their families is free and it also helps veterans with applications for combat-related compensation, certain types of VBA appeals, discharge upgrades, Integrated Disability Evaluation System processing, cases at the Court of Appeals for Veterans Claims and more.
